

## Agrivert Applications for a Composter at Manor Farm Hardwick

The Council, along with numerous residents, successfully opposed these applications which were refused on appeal, primarily on the grounds of safety because of the inherently dangerous entrance and accident history together with adverse impact on the environment including visual, noise, odour and flood risk.

## Street Lighting

Two new additional lights were put in on New Road and the High Street, covering the elevated footpath.

## Neighbourhood Watch and Vandalism

The village is involved with the neighbourhood watch scheme. ## **Minutes**

Minutes of each meeting are issued by the Clerk to the Council and are presented for approval or amendment at the next Council meeting. The unapproved minutes are posted on the village notice board sited at the junction of the High Street and Aston Abbots Road shortly after meetings. This is so that every elector can learn of the matters discussed and actions agreed by their Councillors.

## **Keeping Up Appearances**

The beauty of the surrounding countryside, the character of the buildings and the friendliness of the people enhance the benefits of living in a village. Weedon is no exception and can boast all these things. Even so there is much that has to be done to ensure the appearance of the village is maintained. ## **Planning Applications**

Both Aylesbury Vale District Council and Buckinghamshire County Councils are required to consult the Parish Council about planning applications. The Parish Council hold public meetings to discuss their reaction and all members of the public may attend. An Open Forum is held prior to the meetings at which the details of the plans may be examined, questions asked or comments made, thereby making Councillors aware. The Council cannot approve planning applications; that is the responsibility of the Authorities, but can support, object or make no objections. Individual villagers can respond to any application and the Council try to make everyone who could be affected by an application aware of the meetings via the Notice Boards.

## **Parish Plan**

Many villagers attended the Parish Plan briefing along with the excellent historical display of old pictures. The meeting was a great success and showed strong support from the village to produce a Parish Plan. The steering committee has been established and will shortly set up the working groups who will work towards a plan over the next year. It is essential that every part of the community is involved in generating ideas and giving opinions from the very young to the not so very young!
