24/01182/APP Rectory Farm Buckingham Road Weedon Buckinghamshire HP22 4DR/ Erection of dwelling

JR gave a brief outline of the planning history of the site going back to 2003.

#### JR opened the meeting to an Open Forum.

The residents made the following comments:

- A boundary fence and gate had already been installed and appeared taller than 2 metres.
- Only two parking bays were planned and there was concern about visitor parking.
- The use of the vehicle access drive from the A413 would be intensified.
- The proposed design and height of the new home (a one-storey agricultural-style building) was appreciated. Due to the limited size of the site, if permission were given, they would request a condition that permitted development rights eg. for further outbuildings or additional storeys should be withdrawn.

However, the residents confirmed that they would not be objecting to the application.

#### JR closed the Open Forum.

The Councillors considered their response to Bucks Council and agreed No Objection with added comments about permitted development.
